

A BY-LAW OF THE VILLAGE OF PERTH-ANDOVER TO STOP
UP & CLOSE A PUBLIC STREET IN THE VILLAGE OF PERTH-ANDOVER

The Council of the Village of Perth-Andover hereby enacts under authority of Section 187 of the Municipalities Act;

1. That a portion of Legion Street so called situate in the Village of Perth-Andover, Parish of Andover, County of Victoria and described as follows:

BEGINNING at a point on the division line between the property owned by the Perth-Andover Branch No. 36 Royal Canadian Legion and the property now or formerly owned by The Estate of Gordon Titus, said point having New Brunswick Grid coordinate values of Easting 207780.676 metres and Northing 827356.228 metres; thence along said division line following a New Brunswick Grid azimuth of $343^{\circ} 33' 00''$ 14.422 metres to a Standard Survey Marker found at a point having coordinate values of E 207776.593 m and N 827370.060 m; thence $05^{\circ} 19' 50''$ 26.349 metres to a point having coordinate values of E 207779.040 m and N 827396.295 m; thence $27^{\circ} 46' 10''$ 19.929 metres to a point having coordinate values of E 207788.326 m and N 827413.929 m; thence $54^{\circ} 40' 10''$ 51.764 metres to a point having coordinate values of E 207830.557 m and N 827443.863 m; thence $32^{\circ} 12' 10''$ 49.812 metres to a Standard Survey Marker placed at a point having coordinate values of E 207857.103 m and N 827486.012 m; thence $133^{\circ} 39' 50''$ 20.525 metres to a Standard Survey Marker placed at a point having coordinate values of E 207871.951 m and N 827471.842 m; thence $212^{\circ} 12' 10''$ 49.730 metres to a point having coordinate values of E 207845.449 m and N 827429.762 m; thence $234^{\circ} 40' 10''$ 50.949 metres to a point having coordinate values of E 207803.883 m and N 827400.299 m; thence $207^{\circ} 46' 10''$ 49.808 metres to the point of beginning.

BEING a portion of a street deeded to Her Majesty the Queen by the Perth-Andover Branch No. 36 Royal Canadian Legion in a Deed dated November 06, 1963 and registered in the Victoria County Registry Office January 21, 1964 in book 127 at page 257 as number 52643.

IS permanently stopped up & closed.

2. The Village of Perth-Andover is authorized to hold, lease or otherwise dispose of any right title or interest that it has in the soil and freehold thereof in all or any part of the lands described in Section 1 and is discharged from any obligation to maintain or keep such highway or portion thereof in repair.

READ a first time by title this 8 day of July 1991.

READ a second time by title this 8 day of July 1991.

READ in its entirety, this 9th day of September 1991.

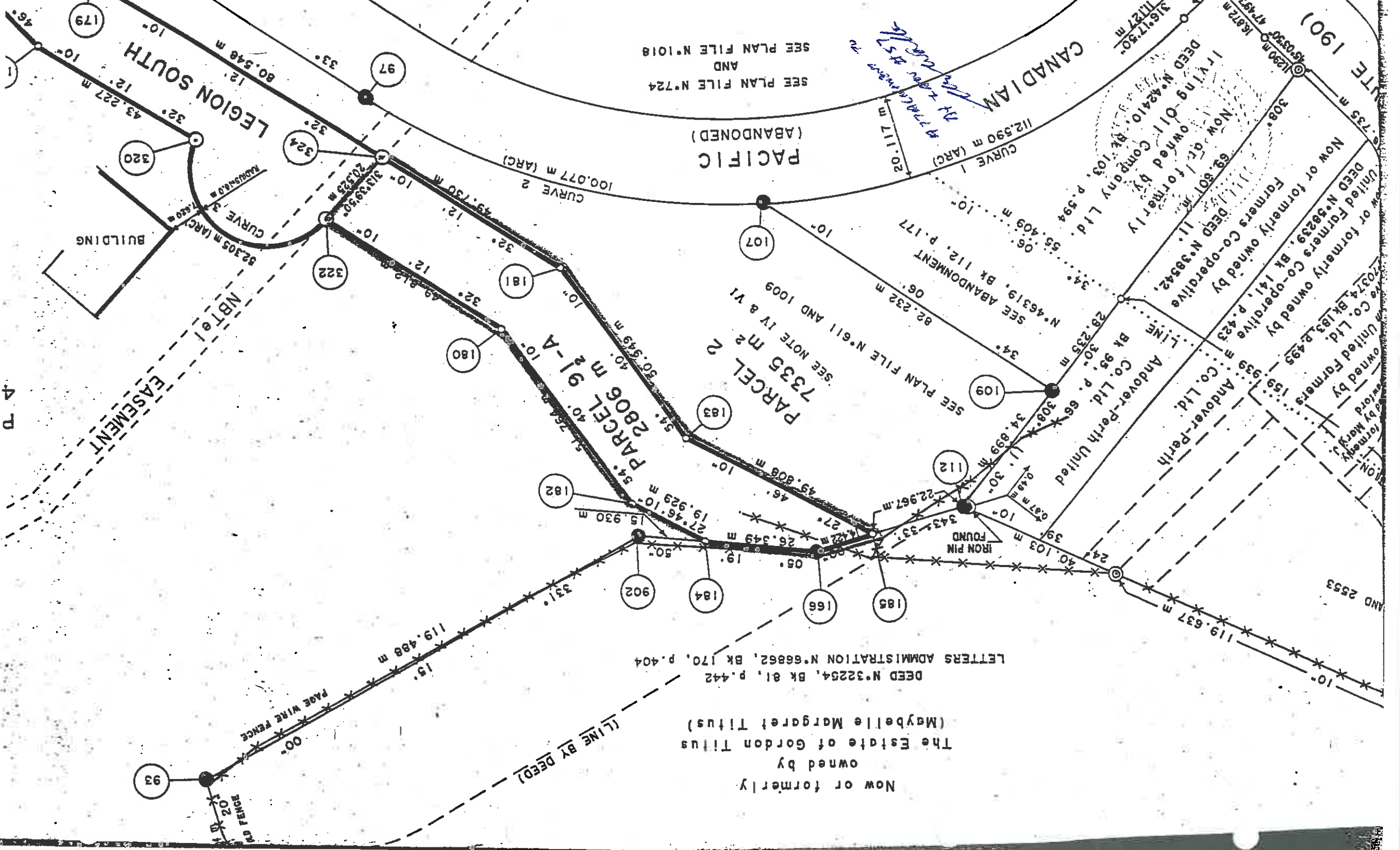
READ a third time by title, and enacted this 9th day of September 1991.
