

BY-LAW NO. 20

A BY-LAW OF THE MUNICIPALITY OF PERTH-ANDOVER

TO REGULATE PARKING AND TO

ASSIST IN SNOW REMOVAL

The Council of the Municipality of Perth-Andover duly assembled hereby enacts as follows:

1. The definitions in section 1 of the Motor Vehicle Act apply to this by-law.
2. In the months of December, January, February and March, between the hours of midnight and 7:00 o'clock in the forenoon of any day, no person shall park a vehicle unattended on any highway. (The provisions of this section are enacted for the purpose of snow-removal.)
3. A peace officer may remove and impound any vehicle which is found illegally parked or causing obstruction to traffic on any highway, and no person shall take possession of a vehicle so removed or impounded until all costs and charges for removal, care and storage of such vehicle have been paid.
4. A person who violates any provision of this by-law is guilty of an offence and is liable on summary conviction to a fine of not more than \$125.00 for each offence, and in default of payment thereof to imprisonment for not more than thirty days.
5. This by-law comes into force on the date of final passing thereof.
